	 To facilitate the training and information of professionals, in an educational and carrievel, technical staff, cultural mediators, volunteers and others in order to remove and avoid the female genital mutilation. To promote the inter-sectorial collaboration of all the institutions related to these practices, in order to accelerate the actions needed to remove or avoid them. Awareness raising the society against the female genital mutilation, making easy the complaint of these situations. Promote the involvement of the citizenship, in particular, minors' education and the collaboration with immigrant associations, especially these focused in removing the inequalities that affect to girls and women. Collect statistical data of the level of implementation of the project and the systematic evaluation in order to make improvement proposals.

2. Creation of an European network of experts on female genital mutilation.

- **a.** Contact in each region with the stakeholders involved and experts in order to form regional experts groups, that all together will form an European network against female genital mutilation.
- **b.** These experts groups of each region will elaborate at a first step the specific information for the training of professionals, families and minors, and will identify Best Practices on that matter (work package 3). It will be discussed also in a meeting with all the partners.
- c. They will collect the overall data that they consider most important for the informative campaign and will identify Best Practices on that matter (work package 4). It will be discussed also in a meeting with all the partners.
- **d.** They will work and elaborate a multi-sectorial action protocol, that will include all the stakeholders involved and will identify Best Practices on that matter (from health, social, judicial, third sector, ect.). It will be discussed also in a meeting with all the partners.

3. Training:

- **a.** Specific training address to healthcare professionals, intercultural mediators, technical staff, volunteers, social workers with practices workshops and elaboration of digital documents.
- b. Specific training address to minors, in particular sons and daughters of immigrants on equality issues, respect to the differences, esteem, etc.
- c. Specific training address to families, about the consequences of these practices, associations where they can find information and help, etc.

4. Dissemination:

- a. **Enable a contact phone**, for information and compliant of possible cases of female genital mutilation.
- b. Informative campaigns. It will consist on materials cultural and linguistically adapted to the communities of immigrants that will be delivered in Healthcare centres and Primary Care centres, social services centres, schools and through social networks.
- c. Elaboration of a project web page. This page will have all the information concern to the project, dissemination material, training materials, forum for the contact between stakeholders. It will be the platform for the European network that will be created by the project.
- d. **Actions for the commemoration** of the "Worldwide day of cero tolerance against the Female Genital Mutilation", the 6th February.
- e. **Tv cartoon commercial** with the information collected along the project.

5. Sustainability plan:

- a. European Network of experts in Female Genital Mutilation. It has been created along the project this European network, that is going to be continued afterwards, taking as base the project webpage.
- **b. Multi-sectorial actions protocol.** It is going to be introduced in the healthcare centres, the social services centres, schools, judicial area, and through all stakeholders contacted.
